**ORDER COMPELLING ML HEALTHCARE, LLC TO PRODUCE DOCUMENTS**


Currently pending before the Court are Non-Party ML Healthcare, LLC's ("MLH") Motion to Quash Subpoena and for Protective Order and Memorandum of Law in Support Thereof, filed on February 13, 2013, and Defendants' Motion to Compel and Opposition to ML Healthcare's Motion to Quash, filed on April 3, 2013 (collectively, the "Motions"). On April 24, 2013, the Court held a hearing at which counsel for the parties and MLH appeared. Accordingly, and for good cause shown,

IT IS HEREBY ORDERED:

1. On or before May 9, 2013, MLH will produce to Defendants all e-mail attachments associated with e-mails MLH previously produced to Defendants, except for attachments that MLH contends contain MLH's confidential and proprietary information.
2. MLH shall file under seal with the Court any attachment that MLH withholds or redacts due to confidentiality concerns.

3. On or before May 9, 2013, MLH will provide Defendants with an itemized invoice for the cost of collecting and producing the e-mail attachments referenced in No. 1, above.
4. On or before May 17, 2013, Defendants will reimburse MLH for collection and production of the e-mail attachments referenced in No 1 above, but such reimbursement will not exceed one thousand dollars (\$1,000.00).


