QUALIFIED PROTECTIVE ORDER

IT IS HEREBY ORDERED that counsel for Defendants LTC Consulting, LP, d/b/a Rockdale Healthcare Center and Arthur H. Grace, Jr. (collectively "Defendants") may conduct informal interviews with decedent's health care providers without counsel for Plaintiffs being present as set forth herein.


Pursuant to federal and state law, counsel for Defendants is hereby authorized to speak informally with decedent's treating physicians and other health care providers without counsel for Plaintiffs being present or participating therein. Specifically, the treating physicians who may be interviewed include: Roopal Desai, M.D.; Steve Tran, M.D.; Jeffrey C. Mitchell, M.D.; Kermie Robinson, M.D.; Andrew Erinks, M.D.; Matthew Taylor Keadey, M.D.; Michael Robinowitz, M.D.; Nirmala Natarajan, M.D.; Jade Brice, M.D.; Nana Abena Arthur, M.D.; and Nimalie D. Stone, M.D. These health care providers may provide records and discuss with counsel for Defendants, the medical care and/or treatment rendered to decedent, which is limited to matters relevant to the care and treatment and medical conditions at issue in this proceeding, namely decedent's decubitus ulcers, which developed on or after February 1, 2009. Decedent's

health information, which includes any oral communication that is/was created or received by a health care provider that is relevant to the care and treatment and medical conditions at issue in this proceeding, may be disclosed to defense counsel, their legal associates, paralegals, investigators, and office staff.

These interviews are conducted at the request of the Defendants, not the Plaintiff, and are for the purpose of assisting defense counsel in this litigation. The decision to engage in such communications lies with the treating health care providers, and they are not compelled by this Order to do so, may choose not to be interviewed, and are not required to engage in *ex parte* communication with defense counsel. Their participation in such meetings is considered voluntary. Defense counsel, however, is not required to produce any notes or memorandum associated with these interviews, which constitute attorney work product. The use or disclosure of any protected health information obtained by defense counsel during *ex parte* interviews is limited to uses and disclosures for purposes of this litigation. At the conclusion of this litigation, defense counsel must either return to the treating health care providers or destroy the protected health information of decedent, including all copies made thereof.

A copy of this Order will be given to each treating healthcare provider.
